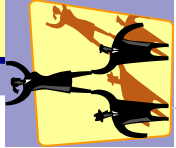


## SDCPA Mission

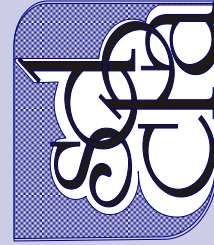
